9. NRCS

11. N-CORPE

Schilling spoke with Kyle prior to the meeting since either he or Loomis were able to attend. Going to change accounting firms from their current one. They are figuring they will have to run the well fields so they are working to get them all up and running within the next two months. The board had voted on an 8% pay raise for Kyle.

12. LEGAL MATTERS

A. Bryan & Ami Hauxwell - Litigation. Vinton stated that the Hauxwell's would like to settle the case and stop with all the legal expenditures. If the board would just grant them their pooling agreement they would drop the lawsuit. They feel as though they have been penalized enough already. Bryan spoke about the cost of money lost in crops they were unable to water due to not being granted the pooling agreement. He stated that he had fixed all the violations and learned where they had went wrong. Ami explained why and how they need and use the pooling.
