1. CONVENE HEARING. The hearing was called to order by Chairman Zink at 1:25 p.m. The agenda was circulated to those present.

The Board Secretary recorded those present. This hearing was recorded by a court reporter. The official Transcript and Exhibits will be filed at the Middle Republican NRD, Curtis, Nebraska.

2. STATEMENT OF PURPOSE

The purpose of this meeting is for the MRNRD to review evidence of alleged violations of the Nebraska Groundwater Management and Protection Act and the MRNRD's Rules and Regulations by Ruggles Farms Inc./Bryan and Ami Hauxwell.

3. DESIGNATION OF HEARING OFFICER

Chairman Zink named Jeffery Ensz as the hearing officer and turned the hearing over to him. Ensz restated the reason the for hearing and the introduction of Jeffrey Cox, attorney for the MRNRD; George Vinton, attorney for Ruggles Farms Inc./Bryan and Ami Hauxwell; and, Ami Hauxwell.

5. OPENING STATEMENTS.

Cox waived his opening statement.

Vinton stated he will limit his testimony based all everything previously submitted in the cases. Requested the Board think about a penalty as being no pooling for this year.

6. PRESENTATION OF EVIDENCE AND TESTIMONY.

Cox offered Exhibit 1 - 9. Vinton: No objection to 1, 4, 5, 7 and 8. Objected to 2, 3, 6 and 9. Ensz noted objection and overruled. Exhibit 1 - 9 received.

Russell was sworn in by McCarter.

Russell was questioned about his history with the MRNRD and his familiarity with the Hauxwell case. Vinton had a number of objections which were all overruled.

Cox offered Exhibit 10. Vinton objected. Noted and overruled. Cox offered Exhibit 11. Vinton objected. Noted and overruled.

Vinton requested additional time. Ensz denied. Vinton went on the question Russell on prior hearings, meetings, board members over the last few years, Blankenau's involvement. Cox objected to some of the questioning. Ensz noted and overruled.

Vinton offered Exhibits 12 -17. Cox: No objection to 14 - 17. Objected to 12 and 13. Ensz noted and overruled.

Nothing further for Russell.

Vinton requested to call Tracy Zink to the stand. Cox objected that it was inappropriate to call a board member to testify on a subject that she needs to make a decision on. Ensz denied the request for Zink to take the stand.

7. CLOSING STATEMENTS

Cox expressed the importance of giving due consideration to Russell's recommendation.

Vinton went on the explain that Hauxwell's tried to cooperate and acted in good faith, they have already endured penalties from not being allowed to pool, expressed a desire to have a hearing with an impartial Board and a number of other items relating to previous hearings.

Ensz turned hearing back over to Chairman Zink.
