1. **CONVENE HEARING.** The hearing was called to order by Chairman Zink at 10:00 a.m. The agenda was circulated to those present.

The purpose of this meeting is for the MRNRD to review evidence of alleged violations of the Nebraska Groundwater Management and Protection Act and the MRNRD's Rules and Regulations by David and Jessica Miller.

Chairman Zink named Jeffery Ensz as the hearing officer and turned the hearing over to him. Ensz restated the reason for hearing and the introduction of Don Blankenau, attorney for the MRNRD and David Miller, representing himself.

Russell stated the Miller had shut off the pivot when he was alerted that he was out of compliance and it has not run since.

Board members asked a number of questions relating to history of land, surface water acres and options that were discussed.

Russell was dismissed.

Miller requested a continuance to get things in order. Ensz denied request. Miller was sworn in by McCarter.

Miller offered Exhibit 7 - 12. Blankenau: No objection. Exhibits 7 - 12 received.

Board members asked a number of questions of Miller as to original certification, why he is selling the property, surface water rights clarification, water report identifying the number of groundwater acres on the property, clarification of how much of the parcel was being sold under the agreement to Hauxwell's and DNR's acres on their website compared to NRD certification documents.

Blankenau made a brief closing statement. Miller also provided a brief closing statement covering the fact he hadn't fully understood the rules.
