# 7. MANAGER'S REPORT

A. WRCF. Russell reported on the meeting with all major players in building a system to connect all our information and build a system to allow for producer access. They are all considered all issues but think they can build what we need.

### 8. COMMITTEE REPORTS

A. Programs: Schilling went over discussions held during the Personnel and Programs meeting and committee recommendations.

Schilling moved to approve the offering of the permanent retirement program with a \$700,000 cap (\$230,000 MRNRD funds) to start immediately and end January 1, 2022. Seconded by Schilling.

Deep Water LLC has approached us to do a large, 3-year tree planting project. We would net around \$30,000 by doing it. Currently, the estimated cost share would be \$56,000 and we have a \$10,000 limit set up.

Schilling moved to waive the \$10,000 cost share limit for the Deep Water LLC 3-year tree planting project. Seconded by Nelsen.

Central Platte NRD will be doing a grazing improvement burn project up in the NE corner of our district as well as their district, Lower Loup and Twin Platte. It was decided to give them \$10,000 to CPNRD over the next 3 years to complete the project.

Our drone needs to be updated preferably with some infra-red capabilities so we have better details identifying water quality inspections. Priced two different drones with capabilities that are needed and it was decided with the rapid changes in technology we would purchase the cheaper one for \$8,000.

Kennedy went over the EQIP deadlines. Currently working on CSP renewals and field work. Attended an interesting training on the tree burning program. He will try to make sure he scans if and gets it emailed to the office so it can be distributed to the board.

Rippen went over the annual meeting. Audit has been completed and he has it available if anyone wants to view it. Their office building has been completed and all setup.

## 12. LEGAL MATTERS

Russell reported that the agreement was almost complete with the Wellfleet community and should be ready for your review next meeting. Lindstrom filed paperwork yesterday for the Hauxwell case.
